

2024 BY THE NUMBERS

In 2024, PCSI provided case management services to over **700 households** from all across Pittsburgh and Allegheny County.

Through our Hunger Trust Fund relationships with six partner pantries, we provided groceries to **10,353 families** across Pittsburgh. PCSI's Pantry Customers brought home over **90 pounds of food each** in 2024.

At Quarterly Pardon Hub + Resource Fairs, PCSI served **798 people**, partnered with **88 employers**, and submitted **38 pardon applications**.



PCSI's front desk received over 2,000 phone and web inquiries in 2024. Of the 1457 households eligible for our support:

- 58% needed assistance paying for utilities (Allegheny County)
- 28% needed housing related assistance (Pittsburgh only)
- 5% needed help finding employment
- 3% needed help applying for a pardon
- 5% needed other or multiple types of help


In 2024, PCSI:


- Welcomed 4 new households into services every day
- Placed an unemployed Pittsburgher in a job every 72 hours
- Kept over 400 neighbors connected to light and heat
- Provided nutritious groceries to 3 people every hour

Of all household members served in 2024...

- o 100% had household income under 200% of the Federal Poverty Income Guidelines
- 26% were working, and 18% were retired
- members served 68% were Black, 23% were white; 3% were Hispanic
 - 25% were children under 18; 11% were 65 and older; 60% were female, 40% male
 - 57% of those over 24 had a High School Diploma/GED or lower level of educational attainment
